POLICY

The Town of Halton Hills, Recreation and Parks Affordability Policy provides direction for effectively allocating public funds for recreational programs. The Town of Halton Hills supports the sharing of Recreation and Parks Resources and the development of partnerships with social service providers to advance the accessibility of recreation and to promote recreation as a response to community needs. The Town of Halton Hills works cooperatively with organizations and levels of government to maximize all sources of funding to facilitate access. Town of Halton Hills will remain financially responsible to all of its residents. Related policies include Municipal Assistance Policy and Inclusion Policy.

PURPOSE

Participation in quality recreation builds essential life skills, self-esteem and confidence. For children who are physically active it can improve school performance and future education expectations. Recreation exposes children to positive role models and gives them opportunities to learn important leadership skills.

Participation in recreation can also have a positive impact on the community. When children from families with low income participate in sport and recreation, their families' need for other services such as social workers, doctors, hospitals, children's aid and medications is reduced (Gina Browne *et al.*, *Benefiting all the Beneficiaries of Social Assistance*, 1999).

Families in receipt of social assistance and additional health and social services such as quality child care and recreation services also reported:

- higher social assistance exit rates (i.e. needed less child care and food bank services, endorsed a high economic social adjustment, received greater child support/alimony)
- reported better mental health for the parents (i.e. fewer nervous, sleep and anxiety disorders - needed less counseling)

(Gina Browne *et al.*, *Benefiting all the Beneficiaries of Social Assistance*, 1999; Gina Browne *et al.*, *When the Bough Breaks*, 1999).

Providing accessible recreation programs for individuals of all ages not only enhances lives today but is also an investment in a healthy community for the future.

DEFINITIONS

Registration Fee: A fee paid to gain access to a recreation program.

Financial Assistance: A subsidy provided that alleviates the total cost or partial cost for a user to access a recreational program.

Financial Need: An economical situation that affects a person's ability to pay.

School Age Care: Services provided to care for children when they need care outside of school hours (i.e. summer programs, March Break, Christmas break and PD days).

SCOPE

The Town of Halton Hills believes that municipal recreation opportunities should be available to all residents. Research shows that recreation is an effective way to improve the lives of low-income families. When Grade 4 students in North Bay, Ontario, were asked to define poverty, their response was the following:

"Poverty means not being able to play soccer or hockey, take swimming lessons, or go on school trips or to camp." (Everybody Get's To Play, Tool Kit, CPRA, 2005).

Poverty has many faces. It can include people already on social assistance, the working poor, parents raising large families on low incomes, single parents on low incomes, seniors receiving the Guaranteed Income Supplement (GIS) and new Canadians. This policy focuses on people of every description who are having difficulty meeting basic needs such as food, shelter, clothing and access to opportunities.

This policy applies to current recreation fees defined in the annual Municipal Rate and Service Charges, and Community Activity and Service Guide.

This policy is in addition to the built-in subsidies for all residents that are included as part of the regular rates and service charges approved by Council.

Related policies include:

- Municipal Assistance
- Inclusion of persons with disabilities
- Property tax grant for seniors on GIS



Guiding Principles

Equitable

All residents of Halton Hills deserve the right to play, and benefit from Town of Halton Hills facilities, programs and services. The Town is committed to removing financial barriers to create equal access to recreation opportunities for low-income families.

Respect & Dignity

The provision of recreation and parks services will be provided in a manner that respects the confidentiality, dignity and independence of all participants.

Coordinated Approach

The Town of Halton Hills will work cooperatively with charitable foundations, the business community, social service agencies, local community recreation/sport providers and levels of government to maximize all sources of funding to facilitate access for individuals and families in financial need.

Consult, Evaluate & Report

The Town welcomes input from residents of Halton Hills through various methods and each year completes a Recreation and Parks internal assessment.

These guiding principles are consistent with Recreation & Parks' Mandate and Values.

Fee Assistance for TOWN Children's Recreation Programs

Halton Region

Halton Region Purchase of Service Agreement for Child Care

The Town of Halton Hills has a Purchase of Service Agreement with Halton Region.

The Town of Halton Hills must meet five eligibility requirements in order to participate in the Purchase of Service Agreement. This includes striving to achieve recognized quality assurance standards. Town of Halton Hills is a registered member of HIGH FIVE®.

Families that are approved for regional child care subsidies are able to use the subsidy to access Town recreation programs for child care needs.

Other Halton Region Funding

This includes families receiving other provincial or federal subsidy programs administered through the Region.

Recreation subsidy is available for children who are receiving child care subsidy or Healthy Babies, Healthy Children programs administered through Halton Region Children Services Division.

Other funds may be available to families receiving National Child Benefit, Ontario Works or Ontario Disabilities Support Program (ODSP) through Employment and Social Services Division.

If applicant is currently not receiving funding from Halton Region then they are considered for the Town's Recreation Subsidy.

Fee Assistance for Children's Community Recreation and Sports Programs

Community

Community Recreation and Sport Providers (CRSP) who are Jumpstart Friendly Organizations

Jumpstart Friendly Organizations:

- Have signed a Jumpstart Friendly Pledge Agreement (Appendix B)
- The organization's Hardship Fund verification is processed by the Halton Hills Jumpstart Chapter
- They pledge to provide subsidized registration fees for a designated number of children each year
- Families apply through Jumpstart

If applicant can not be served through the CRSP Agreement then they are considered for funding by Halton Hills Canadian Tire Jumpstart Chapter.

TOWN Subsidy (Adults and Children)

- Applicant must be a Halton Hills resident
- Applicants must meet eligibility for subsidy (see page 9 for criteria).
- Up to 100% subsidy is available for eligible applicants for one program per session (Winter, Spring, Summer or Fall).
- Day Camps: up to 3 weeks of camp/child (subsidy includes extended care)
- Recreation and Parks also collaborates with other agencies, service clubs to facilitate access to programs.

Canadian Tire Jumpstart (Children and Youth 4-18 yrs)

- Subsidy is available for children 4-18 years of age to register in up to 2 experiences per year, one in spring/summer and one in fall/winter.
- The program can also provide children with equipment and transportation to the activity.
- Canadian Tire Jumpstart is delivered to children in the Halton Hills community through a local Chapter made up of community leaders such as the Georgetown Canadian Tire Store, Optimist Club, Links2Care, Georgetown Bread Basket and Town of Halton Hills.

Process for Recreation Fee Subsidies in Halton Hills



Recreation and Parks will assess each affordability issue on an individual basis.

- All information about applicants will be kept confidential at all times.
- Requests for financial assistance, excluding those receiving GIS, for Town recreational programs will be directed to the Manager of Recreation Services or designate.
- Applicants are first screened to determine if they are eligible to receive support from Halton Region. All federal and provincial funding is managed through Halton Region.
- If applicants do not qualify for Halton Region funding then they will be considered for Town of Halton Hills Subsidy (see pages 8-12).
- Any person (4 -18 years of age) inquiring about subsidies for participation in a community recreation and sport program will be directed to Halton Hills Chapter of Canadian Tire Jumpstart. (see pages 13-14).
- Adults requesting financial assistance for a community recreation and sport program will be referred directly to the sport organization.

I. Halton Region - Purchase of Service Agreement

III. Town of Halton Hills Recreation Subsidy



Resident's wishing to register for a Town recreation program, who do not qualify for financial assistance through Halton Region, may qualify for the Town's Recreation Subsidy program.

- Recreation and Parks will strive to allocate its resources and municipal subsidy to those users in greatest financial need (e.g. low-income households).
- Application information will be kept confidential.

Eligibility and Allocation

- Applicant must be a Halton Hills resident.
- Subsidy is limited to a maximum number of programs/activities per participant, per session (see allocation guidelines below).

Allocation Guidelines:

- Up to 100% subsidy for one program per session per person (Winter, Spring, or Fall)
- Day Camps: up to 3 weeks of camp/child (subsidy includes extended care)
- Each eligible person may receive up to 100% subsidy for recreational passes.
- 50% subsidy for Senior Residents receiving the Guaranteed Income Supplement.

Financial Assistance Registration Process

Steps:

1. Before registering, families or individuals seeking department subsidy must speak with the Manager of Recreation Services or designate to receive approval (with the exception of seniors on Guaranteed Income Supplement (GIS) – see below).
2. Senior citizens receiving GIS are eligible with proof for a 50% subsidy for recreational programs and passes.
3. Manager of Recreation Services or designate advises Registrar of details regarding authorized subsidy (ie. payment plan – see page 11).
4. Registrant submits registration form with balance of payment prior to program commencement.
5. Registrant receives confirmation of registration by mail.
6. Recreation & Parks prepares annual department subsidy report.

Assessment Criteria

Poverty is often defined using Statistics Canada’s Low Income Cut-Offs (LICO). However, this tool alone does not always capture the complexity of financial barriers that prevent individuals and families from accessing recreation. The Town of Halton Hills eligibility criteria reflects a methodology designed to assess the many indicators of poverty using a fair and dignified process.



1. Is the individual or family currently receiving social assistance?

Households or individuals receiving social assistance (i.e. Ontario Works or ODSP) will be automatically eligible for fee subsidy.

2. What is the family’s or individual’s LICO status?

Annual total gross earnings are used to determine a family’s LICO status. (See appendix A for current Income testing scale, based on Stats Canada LICO Index for population of 30,000 to 99,999).

3. What is their Story?

Occasionally there are circumstances where families or individuals are in financial need but this is not reflected in the income testing process. For example, it may be a temporary situation where a family member has become sick, injured or recently unemployed and their income statement from the previous year does not reflect this. It is therefore important to ensure that the process provides an opportunity for the family or individual to tell their story and that there is built-in flexibility in the eligibility process to assist these special circumstances. Other indicators of poverty for the working poor may be the following:

- Food Bank Patrons
- Housing Grants
- Social and health agencies
- Referrals from church, school or other social agencies

Payment Plan

Payment plans to facilitate access to recreational program may be offered with or without a recreation subsidy. Postdated cheques are accepted. Programs must be paid in full two weeks before the program start date.

Procedures for Consultation, Evaluation & Reporting

1 Consultation

Town of Halton Hills Community Member Feedback

Residents of Halton Hills are encouraged to provide feedback with respect to the provision of recreation programs and services by filling out a program evaluation form at www.haltonhills.ca.

Consultation with Community Agencies

The Town continues to foster community partnerships to assist with providing financial aid for residents to participate in recreation programs in the community. This includes building strong relationships with other levels of government, community recreation and sport providers, agencies, service clubs, etc.

2 Communications

Town Website

Information on the Town's financial assistance programs are posted on the Halton Hills website.

Community Activity and Service Guide

Families in financial need that wish to participate in the Town's recreation programs or community sport and recreation programs can learn about the financial assistance programs available in the Town's Community Activity and Service Guide.

F.A.I.R. Financially Assisted and Inexpensive Recreation Guide

This online resource has been designed for professionals working with low income families who wish to refer their clients to affordable recreation activities in Halton. It contains a listing of all free, subsidized and inexpensive recreation services in each municipality of Halton.

3 Evaluation

The unique and diverse needs of recreational participants in Town of Halton Hills programs are evaluated regularly. The Town assesses their ability to provide barrier free access to recreation programs using a variety of evaluation tools and resources including those from the *Everybody Gets to Play – Organizational Assessment Toolkit*. This toolkit can measure an organization’s ability to provide barrier free access to recreation programs in five different categories – Understanding the Issues, Building Awareness, Gaining Commitment, Implementation and Sustainability (*Canadian Parks and Recreation Association, CPRA-ACPL*).

4 Reporting

Recreation & Parks staff report annually on subsidy allocations to the Community Affairs Committee of Council and Halton Region (see Appendix D).

The organizations agree to notify each other within 30 days of a change of contact persons.

The organizations agree to the following tasks for this agreement:

Halton Hills Canadian Tire Jumpstart (HHCTJS) Chapter will assist a child's participation in a sport or recreation activity at *(insert sport organization name)* according to the following guidelines:

- ✓ HH CTJS Chapter will follow all CTJS guidelines.
- ✓ CTJS Charity will provide up to \$300.00 per child in funding for one activity per session.
- ✓ Funding will be provided only for families who have submitted a Jumpstart application and meet the criteria for funding which is reviewed and approved by the HHCTJS Chapter.

- Inform HH CTJS Chapter Contact (Section III, page 4) when a Jumpstart child has not participated in the activity.
- Acknowledge that payment for registration may be delayed and that the amount confirmed by HH CTJS Chapter Contact will be forwarded by CTJS Charities.
- Ensure that all staff and volunteers that process Jumpstart registrations sign a confidentiality agreement.
- Authorize the HH CTJS Chapter and CTJS Charity to promote *(insert sport organization name)* involvement and activities with respect to the Jumpstart program.

V. TERMS OF UNDERSTANDING
